DIRECTIONS

From the Massachusetts Turnpike (Rt. 90) to exit #3. Take a right at the end of the ramp. Take the very next right (about 200') follow dog show signs. Left onto Chabot Rd. to the stop sign. At the stop sign take a right onto Russellville Rd. the fairgrounds will be on the right about 1 mile up the road.

From I-91 to exit 15, Holyoke Mall at Ingelside, turn left at the bottom of the ramp, go to your second set of lights, turn right onto Homestead Ave. At the next light turn left onto Rt. 202. Go approx. 5 miles cross over Rt.10.at the light. Go to the cemetery on your left. At the stop sign take a left onto Russellville Rd. The show sight will be about 1-½ miles down on your left.
